5. Staff Report – Election of Chair and Vice-Chair for 2009

6. Meetings

a) SPC Meeting, January 8, 2009

Alan Arbuckle, SWP Liaison, reported that he attended the first 2009 meeting of the Source Protection Committee on January 8, 2009. The last meeting in 2008 was in August and since then the SWP Terms of Reference have been submitted to the Province. All indications are that they will be accepted. A number of reports were reviewed and a draft meeting schedule discussed with 2009

meetings scheduled every month except February and August. They will be held in different communities in the watershed.

b) RVCA Middle Advisory Board, January 14, 2009

Cathy Willoughby reported that the RVCA Middle Advisory Board met on January 14, 2009, in the Council Chambers, Village of Merrickville-Wolford. Dwight Bennett, the representative from North Grenville retired and was replaced by Barclay Cormack. Elections took place appointing Andy Jozefowicz and Ken Graham as Vice-Chair and Cathy Willoughby as Chair. Cathy reported that the Source Water Protection Update was much appreciated. The Kemptville Creek Flood Plain Mapping report was presented. RVCA Rural Clean Water Update information was summarized and Dell Hallett provided an update on the 2009 RVCA Budget. Montague Township Council sent a letter to RVCA expressing their concern over levy increase.

b. RVCA Upper Advisory Board, January 19, 2009

John H. Miller reported on the RVCA Upper Advisory Board meeting held in the Provincial Court Room, Perth Town Hall, on January 19, 2009. Michael McEwen and David Crowley are again Vice-Chair and John H. Miller remains as Chair. Reports on the Haggart Island Dam Project, the Rideau Lakes Watershed Plan, a Planning Report and Watershed Watch Program presentation by RVCA staff were well received. Dell Hallett reported on the RVCA 2009 Budget. A discussion took place on future meeting dates and a revised schedule will be attached to the minutes. Dell provided information on the RVCA Rural Clean Water Program.

Ed Hand asked about the \$501,171 payment to the City of Ottawa for the Rideau River Ice Management Program. Dell responded that the RVCA is able to get a grant from the Province and sets a special levy to the City to finance the program each year.

8. Staff Report – Appointment of Auditors

9. Staff Report –Appointment of Legal Advisors

That the firm of Bell Baker, Barristers and Solicitors be retained as legal advisors for 2009 and furthermore that other legal counsel be retained as required.

10. Staff Report – Borrowing By-Law

Carried on consent.

That, in 2009, the signing officers of the RVCA be authorized to borrow up to a maximum of \$750,000, which may be required for the purpose of the RVCA to implement its program, until payment to the RVCA of any grants, levies or other revenues.

11. Staff Report – Appointments to Executive Committee

Dell Hallett reported that the Executive Committee hears applications for permits associated with the RVCA Fill, Construction and Alteration to Waterways Regulation. Since the RVCA adopted a written policy, there have been approximately six hearings per year. The Executive Committee has six members. The Chair and Vice-Chair are automatically appointed.

That the RVCA Board of Directors approve payment in the amount of \$27,449. to Conservation Ontario for the 2009 levy to the RVCA.

14. Staff Report – Member’s Per Diem & Chair’s Honorarium

Discussion took place on the merits of increasing the per diem by cost of living increase each year. Several members, however, pointed out that the rate is now the lowest being paid as compared to other meetings they attend and although the increase from \$57 to \$60 is more than the current cost of living increase, by increasing a few dollars each year, there is the opportunity to catch up. It was noted that the Councillors appointed to the RVCA Board of Directors, do not receive the per diem or the mileage as directed by the City.
