New Improved RVCA Board of Directors New Governance Structure for Board of Directors

January 27, 2011 was the first annual meeting of the new and improved RVCA Board of Directors. The Board, made up of municipal representatives, has expanded to include each member municipality. What was previously a twelve member board has grown into a 22 member board (one from each of the sixteen rural municipalities plus six representatives from the City of Ottawa).

RVCA prides itself on being a local, grassroots, municipally driven organization. We are pleased to reflect the needs of our members. In 2010, Chair Alan Arbuckle and RVCA staff asked member municipalities as to their preference in how they would like to be represented at the Board level. In response to municipal interests, the board has expanded to include all municipalities at the table.

RVCA Executive Committee

What is the RVCA Executive Committee? Executive Committee is a sub-committee of the Board of Directors which hears applications for permits associated with RVCA's *Ontario Regulation 174/06—Development, Interference with Wetlands and Alterations to Shorelines and Watercourses Regulation*. Hearings are held, at the request of an applicant, when an application for development or interference or alteration can not be approved at a staff level because it does not comply with the Board of Directors approved policy. A citizen may also appeal conditions of approval where permission has been granted. The Executive Committee has five members and automatically includes the Chair and Vice-Chair of the Board of Directors. This year's members are Alan Arbuckle, Ken Graham, John Miller, David Crowley and Ed Hand with Barclay Cormack as an alternate. (don.maciver@rvca.ca)

Time to Review Municipal Flood Response

RVCA has the responsibility for Flood Forecasting and Warning (FF&W) in the Rideau River watershed. The RVCA's FF&W system is in operation 12 months a year — monitoring the weather and watershed and issuing advisories as local situations warrant. Should a flood event occur, the first response is up to the individual homeowner. If the flood is beyond the capability of the homeowner to combat, municipal Emergency Response Plans kick-in to assist those in need. Now is the time for municipalities to review their emergency response plan and make sure all employees, equipment and communications are in place just in case. The RVCA will issue the first long range forecast by March 1 or earlier based on weather conditions. (patrick.larson@rvca.ca)
